
We're lucky to have some stunning destinations for our mystery bus tours. Tasmania has such beautiful scenery, and we love finding hidden gems to admire.

## A vexillologist in our midst

Graeme Cairns joined the Bisdee Community Centre 18 months ago and attends regularly, occasionally staying at Hotel Bisdee for respite care. He enjoyed a lot of bus trips last year and now likes various in-house activities from the Bisdee program.

Graeme told us about his interest in vexillology, the study of flags, and held an exhibition for Bisdee clients and staff on 5 February.

attending their conferences.





## Looking out for us all

#### The new Aged Care Act

As part of the Royal Commission into Aged Care Quality and Safety, it was identified that the current Aged Care Act is no longer fit for purpose.

The current act is structured around providers and how to fund them, not about the people accessing and receiving the services they need.

The new Act is focused on the journey of older Australians and prioritises their needs.

The new Act is due to come into effect 1 July 2024. It will replace existing legislation, including the current Aged Care Act and the Aged Care Quality and Safety Commission Act 2018.



The new Act will:

- create a simple, single-entry point to make access to the aged care system for older people easier
- include a fair, culturally safe single assessment process
- include rules on supported decisionmaking to ensure older people have choice and control
- provide additional protections for whistleblowers to allow reporting without fear of reprisal
- introduce a new approach to regulating aged care providers to ensure the delivery of safe, quality aged care services
- strengthen the powers of the regulator, the Aged Care Quality and Safety Commission, to manage risk, ensure integrity, and support aged care.
- replace the Charter of Aged Care
  Rights with a Statement of Rights which
  will include pathways for reporting,
  including complaints.

The passing of this new legislation means significant changes and impacts on providers, including changes to registration and accreditation, audit assessment visits, systems and processes, policies and procedures, and changes to the regulatory framework.

However, these changes are welcomed, with the shift towards older Australians and their journeys.

#### Strengthened Standards for Aged Care

Along with the new Aged Care Act, the strengthened Quality Standards are expected to be introduced from 1 July 2024.

This is in response to recommendations from the Royal Commission into Aged Care Quality and Safety by the Department of Health and Aged Care.

These strengthened Standards come into effect once the Age Care Act is passed by Parliament.

Some points we've learned so far:

- The strengthened Aged Care Quality Standards (strengthened Quality Standards) set out the standards that need to be met by registered providers to deliver aged care services to older people, this is unchanged from the current standards.
- They describe a range of outcomes that providers must achieve to deliver safe and quality aged care services that meet the older person's needs, goals, and preferences.
- There will be a change in provider registration categories and registration processes.

• There will be 7 Standards, instead of the current 8 Standards.

Standard 1: The Person

Standard 2: The Organisation

Standard 3: The Care and Services

Standard 4: The Environment

Standard 5: Clinical Care

Standard 6: Food and Nutrition and

Standard 7: The Residential Community

- The standards change from 'met' and 'unmet' to a graded assessment: conformance, minor non-conformance, major non-conformance, and exceeding.
- There are clearer expectations of safe quality care and help to guide providers to lift their performance and deliver the care expected by older Australians.

As a consumer receiving care and services, you remain at the centre of all that we do. There is a greater focus on the older person and a clearer outline of your rights and decision-making.

#### Dear all,

Glenview is regularly required to meet quality standards to continue to operate and this year Windsor, Korongee, Community Services, and NDIS services are **all** being assessed for reaccreditation.

It was certainly not our desire to have these accreditation cycles land in the same year, but on the plus side, it keeps us focused on working to support these processes in 2024.

The standards focus on outcomes for consumers and reflect the level of care and services our consumers can and should expect from Glenview.

This includes consumer dignity and choice, ongoing assessments and planning with consumers, and personal and clinical care.

The Glenview team and I look forward to working with our clients, consumers, residents, and families as part of this important process.

There are soon to be important changes to our existing aged care standards as per the recommendations of the Royal Commission. The Commission places a particular focus on:

- food and nutrition
- dementia
- diversity
- governance
- clinical care.

We are working closely to map, better understand, and coordinate what the new standards mean for our teams and consumers - including training and support to help implement them.

They were originally due to start with the revised Aged Care Act in July, but we believe there will be some delays. What we do know is outlined on pages 8 and 9.

I would like to personally reach out to families and representatives to come along and engage in our **resident and representative meetings** held monthly at both Windsor Street and Korongee.

Our Windsor Street meetings are gaining in numbers, which is a great sign of the levels of engagement. The meetings are open to family, representatives, and friends and can be joined virtually through Zoom. They are a great way to meet our growing team who oversee resident care and services, and who you may not always meet when visiting.

A reminder that we REALLY want to hear from you and your representatives as part of our consumer surveys. This annual (anonymous) survey is designed to reach out to everyone across most of Glenview's services.

Have your say, help us check how we are doing and enable us to set our priorities based on the results. Please keep an eye out for the survey and complete either in hard copy or electronically.
